

Terms of Service for LeParadis.app

1. Introduction

Welcome to LeParadis.app ("we," "our," or "us"). These Terms of Service ("Terms") govern your access to and use of our website, mobile application, and services (collectively, the "Service"). Our Service is owned and operated by Le Paradis D.O.O., a company registered in Serbia.

By accessing or using our Service, you agree to be bound by these Terms. If you disagree with any part of the terms, you may not access the Service.

2. Description of Service

LeParadis.app provides an online platform that allows service providers ("Sellers") to list and sell their services, and customers ("Buyers") to book and purchase these services. We facilitate the connection between Sellers and Buyers but are not a party to any transaction between Sellers and Buyers.

3. User Accounts

3.1. To access certain features of the Service, you must register for an account. You agree to provide accurate, current, and complete information during the registration process and to update such information to keep it accurate, current, and complete.

3.2. You are responsible for safeguarding the password that you use to access the Service and for any activities or actions under your password.

3.3. You agree not to disclose your password to any third party. You must notify us immediately upon becoming aware of any breach of security or unauthorized use of your account.

4. User Content

4.1. Our Service allows you to post, link, store, share and otherwise make available certain information, text, graphics, videos, or other material ("Content"). You are responsible for the Content that you post on or through the Service, including its legality, reliability, and appropriateness.

4.2. By posting Content on or through the Service, you grant us the right to use, modify, publicly perform, publicly display, reproduce, and distribute such Content on and through the Service.

5. Payments and Fees

5.1. All payments on the platform are processed by our third-party payment processor. By using our Service, you agree to be bound by the payment processor's terms of service.

5.2. We are not responsible for any errors or losses made by the payment processor.

5.3. We reserve the right to change our fees at any time. Any changes to fees will be notified to users in advance.

6. Seller Obligations

6.1. Sellers are responsible for the accuracy of their service listings, including descriptions, availability, and pricing.

6.2. Sellers must fulfill their booked services as described in their listings.

6.3. Sellers are responsible for complying with all applicable laws and regulations related to their services.

7. Buyer Obligations

7.1. Buyers agree to pay for services booked through the platform.

7.2. Buyers must comply with any specific terms or conditions set by Sellers for their services.

8. Prohibited Activities

You may not access or use the Service for any purpose other than that for which we make the Service available. The Service may not be used in connection with any commercial endeavors except those that are specifically endorsed or approved by us.

9. Termination

We may terminate or suspend your account and bar access to the Service immediately, without prior notice or liability, under our sole discretion, for any reason whatsoever and without limitation, including but not limited to a breach of the Terms.

10. Limitation of Liability

In no event shall LeParadis.app, nor its directors, employees, partners, agents, suppliers, or affiliates, be liable for any indirect, incidental, special, consequential or punitive damages, including without limitation, loss of profits, data, use, goodwill, or other intangible losses, resulting from your access to or use of or inability to access or use the Service.

11. Governing Law

These Terms shall be governed and construed in accordance with the laws of Serbia, without regard to its conflict of law provisions.

12. Changes to Terms

We reserve the right, at our sole discretion, to modify or replace these Terms at any time. What constitutes a material change will be determined at our sole discretion.
